


Each fall, the Colorado Department of Education (CDE) individually ranks Colorado's 179 school districts using a complex formula that is broken down into three key performance indicators: Academic Achievement, Academic Growth, and Postsecondary and Workforce Readiness. While establishing each district's official accreditation rating, CMAS, PSAT and SAT results, along with drop-out and graduation rates among other factors are considered. After all the numbers are crunched, the District falls into one of the following five Accreditation Categories (from least to most desirable):

Accredited w/Turnaround Plan Accredited w/Priority Improvement Plan Accredited w/Improvement Plan Accredited Accredited w/Distinction

CDE recently released their 2018 District Performance Frameworks, and I am pleased to announce that Idalia District RJ-3 has achieved the second highest rating possible: Accredited. The hard work and dedication shown by both our students and staff on a daily basis is reflective of our district's rating. Our students were specifically impressive with their PSAT/SAT results, where collectively this years' junior and senior classes scored at the 66<sup>th</sup> percentile on Reading and Writing and at the 55<sup>th</sup> percentile in Math. Idalia's almost non-existent dropout rate, along with our essentially perfect graduation rates also go a long ways towards boosting our final rating. Although we can take pride in our past achievements, we must at the same time identify areas in which we can improve. Upon analyzing and reviewing the data, areas of improvement that have been identified include CMAS results along with closing the ethnic gap between our ELL and non-ELL populations. As District leadership continues to brainstorm and discuss ideas of how to best address these targeted areas of improvement, we are not only proud of our recent rating, but also confident that even higher achievement lies ahead. *Submitted by Myles Johnson, Superintendent*

## What is FAFSA? The free application for federal student aid

# To maximize your potential aid, you should submit a FAFSA form as early as possible after October 1

Completing a FAFSA is the first step in applying for most federal, state, and college-provided financial aid for students. It stands for <u>Free Application for Federal Student Aid because it is filed with the US Department of Education</u>, but most state-sponsored and college-sponsored aid requires the same FAFSA filing, so it is not only for federally sponsored student aid as the name might imply. The FAFSA is used by aid providers to determine the amount of the student's Expected Family Contribution (EFC), which is the amount that they expect the student's family could contribute toward the student's college education. EFC varies from student to student since it is based on the specific financial situation of the student and often of the student's parents as well.

The FAFSA is often 100+ questions long and can cover various areas such as the student's family situation, the student's educational background, the student's educational plans and prospective colleges, the student's finances, the student's spouse's finances, and the student's parents' finances. Whether or not parent financial information is required depends on whether or not the student is determined to still be a dependent of one of their parents.

## Who is eligible for federal student financial aid?

Most people are eligible for some form of student financial aid, even if just for low-interest loans. To determine if you are eligible, you must file a FAFSA application. However, following is a checklist you can use to determine if you may be eligible even before filing a FAFSA. If all of the following apply to you, you can take that as a good predictor that you will be eligible for at least one form of financial aid for higher education:

The student has received their high school diploma or GED certificate (General Education Development). The equivalent of a high school education completed in a home school setting is also acceptable, as determined by the law in your state.

You have a Social Security Number that is valid.

You agree that any financial aid received will only be used for educational expenses.

You are a valid citizen of the US, a permanent US resident with a valid Permanent Resident Card, or a US national. In other cases, you may receive financial aid if you are an eligible non-citizen.

If the student is a male between the ages of 18 and 25, they must agree to let the FAFSA register them with the US Selective Service, or they must already be registered.

## I'm not sure I will qualify for financial aid. Should I still file a FAFSA?


We encourage all students to file a FAFSA application to apply for student financial aid. Generally, most people are eligible for some form of aid, regardless of the income of the student or their parents. Billions of dollars in aid are available every year, including scholar-ships, grants, low-interest loans and work-study programs, and the FAFSA is the first step in applying for most of that aid.

## What if I am undocumented?

In most cases, no student's academic status will be effected by an undocumented status. As long as the student is aware that they will not qualify for federal financial aid, they will not have any other trouble with becoming a student. Since they would not qualify for financial aid, they would just need to set up a payment plan at the beginning of the term to make payments on their balance. Their first step would be completing an application for the college and following the instructions they receive via email/mail.



## Statistics Class Surveys



#### FOR OR AGAINST VACINATIONS



This November, Amendment 73 will appear on ballots throughout Colorado. The Colorado Association of School Boards (CASB) prepared the following fact sheet on how Amendment 73 could impact Idalia School District RJ-3 and its constituents. ## Amendment 73 Factual Summary for Idalia Rj-3 School District



#### What is Amendment 73?

Amendment 73 (A73) is the result of the <u>citizen's ballot initiative #93</u>, known as *Great Schools, Thriving Communities* (GSTC). A73 is a statewide school funding initiative that will increase income taxes for 8% of tax filers and for C Corporations, while decreasing property taxes for business property owners, farmers and ranchers. It will:

- stabilize and increase funding statewide for preschool through twelfth grade (P-12) public education
- create the Quality Public Education Fund that can only be used for public education, is exempt from the TABOR revenue limit, must be used to supplement General Fund appropriations for P-12 public education, and is adjusted each year for inflation up to 5 percent

#### How would it impact funding for Idalia Rj-3 School District?

Based on the most recent CDE estimates for 2018-2019, Idalia Rj-3 School District would receive **\$0.5 million in** additional ongoing revenue if the initiative were implemented for the 2018-2019 school year.

The A73 estimate is based on current student count and demographics that are subject to change. Funding estimates will be revised when updated data is released.

## How is funding stabilized and raised?

A73 is a property tax decrease for nonresidential property owners and it stabilizes the local share of school funding by permanently setting property tax assessment rates. A73 will prevent future reductions to the residential assessment rate (RAR) as currently required by the Gallagher Amendment. It permanently sets the RAR at 7% (currently 7.2%), and decreases and permanently sets the assessment rate at 24% (currently at 29%) for business property owners, farmers and ranchers — **for property taxes levied by school districts**.

A73 is an income tax increase for 8% of Colorado tax filers with taxable income *(income after exemptions and deductions)* over \$150,000. In addition, A73 increases the state corporate income tax rate by 1.37% for "C" Corporations (does *not include LLCs, sole proprietorships and S corporations*). A73 raises \$1.6 billion in revenue that is deposited in the Quality Public Education Fund.

#### How will the revenue be spent?

The initiative allows school districts to make local decisions about the best use of new funds that reflect local community priorities and needs — examples of how funding could be used include programs supporting mental health, safety and security, career and technical education, school maintenance and repair needs, reducing class size, etc.

#### How are property taxes for other local governments impacted?

A73 cuts property tax assessment rates *only* for property taxes levied by school districts. Property taxes levied by other local governments are unaffected by A73.

#### Will the drop in property tax rates hurt school funding?

No. Setting the residential assessment rate at 7.0% and the nonresidential assessment rate at 24% for mills levied by school districts, the measure decreases local property tax revenue to fund P-12 public schools in FY2019-2020. However, under the School Finance Act, each district's local share is calculated first, and state aid makes up the difference between the local portion and the total funding need identified through the formula.

## What percentage of tax filers will be impacted in Yuma county and by how much?

The income tax change will impact tax filers with taxable income over \$150,000. Income of \$180,000 is estimated to equate to \$150,000 in taxable income (income after deductions and exemptions). According to the US Census Bureau data, Yuma county tax filers fit this profile:

- Average income: \$57,131
- Percent of taxpayers with income between \$150,000 and \$200,000: 3%
- Percent of taxpayers with income over \$200,000: 3%

## **Arguments For**

- The state needs a sustainable source of revenue to adequately and equitably fund public education.
- The measure provides property tax relief for business property owners, farmers, and ranchers who have paid an increasingly higher proportion of property taxes compared to residential property owners.
- One of government's most important functions is to provide children with a high-quality education.
- Stabilizing the local share of required school formula funding and creating a dedicated source of state revenue for education provide additional flexibility for the state to use more of its general operating budget on other core programs, such as transportation, public safety, and health care.


## **Arguments Against**

- The measure imposes a tax increase without any guarantee of increased academic achievement.
- Increasing the state income tax rate could negatively impact the state's economy. Businesses will have less money to invest in their workers and individuals will have less money to spend, save, and invest.
- The measure complicates an already complicated property tax system. By creating one assessed value for school districts and another assessed value for all other local taxing entities, the measure will lead to confusion among taxpayers and further complicate tax administration for state and local governments.
- The measure does not allow the state legislature to adjust the income tax thresholds to account for inflation.

## SCHOOL CELEBRATES HEALTHY SCHOOL FOOD


The Idalia Health & Wellness and the talented kitchen staff are pleased to share the results of the LiveWell Colorado School Food Initiative, a program providing culinary, operations, and marketing assistance to school districts across the state. Idalia School participated in this 2-year program from 2016-2018, with the goal of reducing processed food and providing new, healthy menu items to its school community.





Apart from a few processed foods hard to replace (ketchup, salad dressing, pepperoni & OJ concentrate, to name a few), the Idalia kitchen staff has made significant improvement in creating menu items from scratch. In addition, the staff has identified cost-saving strategies, reduced food waste, and increased the variety of fresh produce in the salad bar. These modifications have resulted in increased participation in the school lunch program at Idalia.

The Idalia Health & Wellness committee continues to support the school food program, along with other healthy living activities such as: National Walk & Bike to School days, Father-Daughter Dance, 3-on-3 Bas-ketball Tournament, Walking School Bus, Bike Rodeo and Family Fitness Sundays.
